# **Toner Pirates:**

## How to Avoid A Scam & What to Do if You're a Victim



#### What are toner pirates?

Toner pirates, also called toner phoners, are fraudulent companies that misrepresent themselves in order to attempt to sell supplies at outrageously inflated prices. A growing number of Atlanta based companies have been taken advantage of by these fake toner phone calls. These "toner pirates" call pretending to be your regular supplier offering to ship replacement toner for your machine then send a bulk shipment with a large price-tag. They may call several times in order to collect information to sound more legitimate on future calls.



## How can I avoid becoming a victim? Here are a few toner pirate facts and tips on how to protect your company:

- Have a specific individual(s) responsible for ordering supplies. It's easier for them to take advantage of you if no one person is responsible and they can collect bits of information from different people.
- If someone contacts your company using general terms claiming to be your "copier company" or "copier service company" ask for a callback number- the caller usually hangs up.
- Beware of callers that avoid giving their firm's name. Never place a supply order over the phone if you are unable to identify the organization.
- Ask the caller to verify your account number, equipment ID number, make and model, and as much information as possible. Your real copier company will be able to provide any of your information but toner pirates will only be able to provide what they've been able to glean from calling your office.
- Advise all employees of the name and contact information for your current supplier to avoid being scammed.
- Never give out information about your equipment such as serial numbers or machine type to telemarketers.
- Do not pay invoices unless they match your current contract.



### What do I do if I already ordered supplies from a toner pirate?

If an individual in your office accidentally placed an order with a toner pirate make every attempt to refuse the acceptance upon delivery. If the package gets received, ship the package back to the sender. Here are several further options to report the fraud, pursue further action, and help stop these scamming companies.

1.) Send a letter of rejection to the fraudulent telemarketer via certified mail, and send a copy of it along with a copy of the invoice to the BTA (Business Technology Association), the State of Georgia Attorney General, and the Office of the Attorney General in the fraudulent telemarketer's state:
